Investment Strategy

The fund may invest in global real estate securities, property related securities and participatory interests in collective investment schemes in property listed on exchanges, non-equity securities and assets in liquid form. In addition it may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes. Participatory interests or any other form of participation in these schemes will be included in the portfolio only where the regulatory environment is to the satisfaction of the Manager and the Trustee, and being of a sufficient standard to provide investor protection.

The fund may from time to time invest in financial instruments, in accordance with legislative provisions thereto, as amended from time to time, in order to achieve the portfolio's investment objective. The manager may also include forward currency, interest rate and exchange rate swap transactions. The property exposure will always exceed 75%.

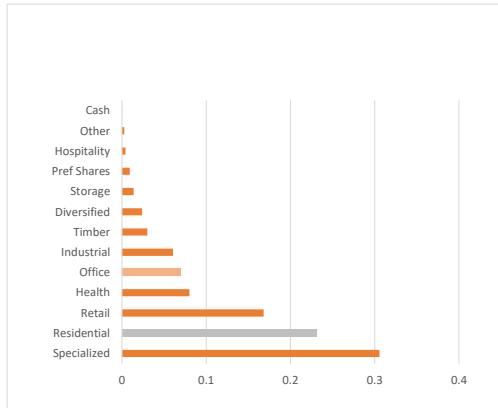
Investment Objectives

While the fund's primary objective is to generate high current income, investors will reap the inherent benefits of capital appreciation that come with real estate assets.

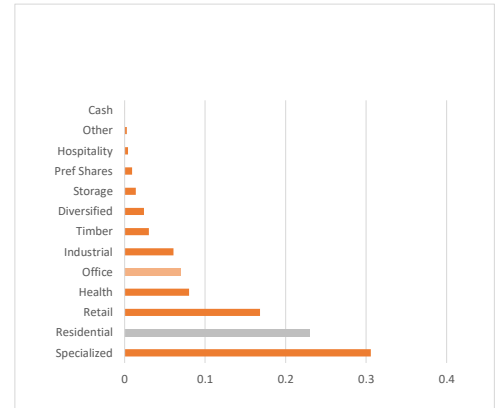
